P. 9037). The Electronic Case Filing system does not redact the content of any document uploaded by the filer.

Slide 20 - NOTICE OF ELECTRONIC FILING



The **Notice of Electronic Filing** for the Withdrawal of Claim appears. The notice displays the docket text indicating the specific Claim Number information and the creditor-filer.

An e-mail of the Notice of Electronic Filing is transmitted to the e-mail address indicated on the filer's ECF account. In the e-mail filers must select the *Document Number* hyperlink to view the Withdrawal of Claim. This is referred to as the **Free Look**. If the filer loses the Free Look the filer must query the docket through PACER.

Notice will be electronically mailed - Identifies the parties in the case who will receive electronic notice of the filing in their e-mail account.

Notice will not be electronically mailed - Identifies the parties in the case who will not receive electronic notice of the filing and must be served conventionally.
